WHEREAS, this activity is statutorily exempt from the California Environmental Quality Act [CEQA] pursuant to CEQA Guidelines Section 15262; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor be and he is hereby authorized and empowered to execute, for and on behalf of said City, an Agreement with Wallace, Roberts & Todd, LLC, for Urban Design Services for the Uptown Community Plan Update under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR 305042

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$150,000 from the City Planning & Community Investment Department FY 2009 Operating Budget is authorized for the purpose of providing funds for the above referenced Project, provided that the Comptroller first furnishes one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.
