A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE GENERAL PLAN ACTION PLAN – IMPLEMENTATION PROGRAM FOR THE GENERAL PLAN.

WHEREAS, the General Plan was adopted by City Council on March 10, 2008, by Resolution No. R-303473; and

WHEREAS, the General Plan sets out a long-range vision and comprehensive policy framework for how the City should plan for projected growth and development, provide public services, and maintain the qualities that define San Diego over the next 20 to 30 years; and

WHEREAS, the next step to implement the goals and policies of the General Plan is approval of the General Plan Action Plan [Action Plan], which outlines the strategies and tools needed to bring together policy and action; and

WHEREAS, the Action Plan identifies eight priorities for implementation: Community Plan Updates, Climate Change Initiatives, Water Supply & Conservation Efforts, Land Development Code Amendments, Public Facilities Finance Strategy, Economic Development Strategic Plan, Parks Master Plan, and Historic Preservation Incentives; and

WHEREAS, on June 18, 2008, the Land Use & Housing Committee [LU&H] held an informational workshop on the Action Plan, and on March 11, 2009, the LU&H recommended City Council approval of the Action Plan; and

WHEREAS, on January 28, 2009, the Natural Resources and Culture Committee [NR&C] heard an informational update on the Action Plan, and on April 22, 2009, the NR&C discussed Action Plan items relating to the Recreation and Conservation elements of the General


Plan as well as water, wastewater, and storm water; the NR&C recommended forwarding the Action Plan to City Council for adoption; and

WHEREAS, on February 19, 2009, the Planning Commission recommended that the City Council approve the Action Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council hereby approves the General Plan Action Plan on file in the Office of the City Clerk as Document No.
