A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO ACCEPTING THE CITY AUDITOR REPORT  
DATED JUNE 1, 2009, ENTITLED "QUALCOMM STADIUM  
AUDIT"

WHEREAS, on June 1, 2009, the City Auditor prepared and delivered a performance  
audit report to the Audit Committee entitled "Qualcomm Stadium Audit" [Report]; and

WHEREAS, the Report found that the City faces unique operating and administrative  
challenges managing Qualcomm Stadium including without limitation that Stadium operations  
lose money every year and must be funded through the Transit Occupancy Tax revenue and  
other non-stadium asset revenue; and

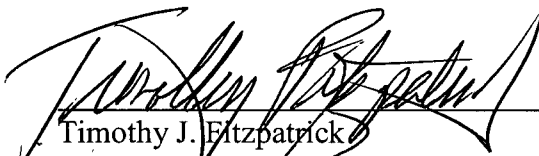
WHEREAS, on June 1, 2009, the Audit Committee approved the Report and forwarded  
it to the City Council with the recommendation that the Report be accepted and approved, and  
that the Council direct the Stadium Advisory Board and Qualcomm Stadium Management to,  
within 12 months from the date hereof, prepare a report to the Mayor and Council  
outlining: (1) options to mitigate net operating losses of Qualcomm Stadium operations,  
and (2) analysis of scenarios if Chargers stay or leave Qualcomm Stadium after 2011; NOW,  
THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Qualcomm  
Stadium Audit Report dated June 1, 2009, is accepted.

BE IT FURTHER RESOLVED, that the Qualcomm Stadium Advisory Board and  
Qualcomm Stadium Management are requested to provide a business plan to the Mayor and

Council within ninety (90) days from July 13, 2009 and to include : (1) options to mitigate net operating losses of Qualcomm Stadium operations; and (2) analysis of scenarios if Chargers stay or leave Qualcomm Stadium after 2011.

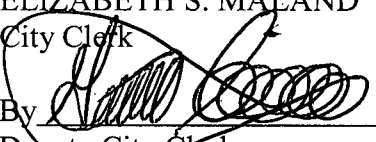
