

RESOLUTION NUMBER R- 305086

DATE OF FINAL PASSAGE JUL 22 2009

WHEREAS, on April 15, 2002, the City Council introduced an ordinance, on file with the Office of the City Clerk as Document No. OO-19053, and codified at San Diego Municipal Code sections 26.1601 to 26.1605, establishing a City of San Diego Youth Commission [the Commission]; and

WHEREAS, the Commission was created to serve as an advisory body to the Mayor, City Council and City Manager on issues of interest to youth and pertaining to youth in the City of San Diego; and

WHEREAS, the Commission was created to facilitate the participation of youth and young adults in local government, as well as to provide City officials an opportunity to hear and address their ideas and concerns; and

WHEREAS, the Municipal Code states that the Commission will have 18 members, who shall serve two-year terms and serve until a successor is appointed and confirmed; and

WHEREAS, the Municipal Code requires the Mayor to appoint 2 members from each Council member's list of nominees, for a total of 16; and 2 additional members chosen by the Mayor; and

WHEREAS, the Mayor now seeks to fill 17 vacancies on the Commission due to the term expirations of Dorothy Habrat, Ross Thompson, Ashley Grand, Sarah Jafari, Kim Truong, Anarie Salvador, Vanessa Houston, Hoa Vo, Michael Fiszman, Roosevelt Williams, Hannah

Keck, Haley Elwood, Julie Saba, Lena Slater, Monica Daniels, Kayleigh Neel and Greg Elenbaas; and

WHEREAS, the Mayor seeks to appoint 17 new Commissioners, including those nominated by members of the City Council, and subject to confirmation by a majority of the City Council; NOW, THEREFORE,


