A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE REQUEST OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO TO EXTEND FOR AN ADDITIONAL PERIOD OF FIVE YEARS (PURSUANT TO CALIFORNIA HEALTH & SAFETY CODE §33334.16) THE TIME BY WHICH AFFORDABLE HOUSING MAY BE DEVELOPED ON CERTAIN REAL PROPERTY ACQUIRED WITH LOW AND MODERATE INCOME HOUSING TRUST FUNDS LOCATED AT 1034 AND 1036 EUCLID AVENUE, SAN DIEGO, CALIFORNIA 92114.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] acquired an interest in that certain real property identified as San Diego County Assessor's Parcel No. 542-480-18 located at 1034 and 1036 Euclid Avenue, San Diego, California 92114 [Property] on October 21, 2005 for the purpose of causing the development of certain affordable housing [Affordable Housing] exclusively for persons and families of low and moderate income [Oualified Persons].

WHEREAS, the Property is located within the Central Imperial Redevelopment Project Area; and

WHEREAS, due to certain economic conditions, the Agency has been unable to initiate or cause the initiation of activities necessary and consistent with the requirements of Section 33334.16 of the Health and Safety Code providing for the development of the Property as Affordable Housing; and

WHEREAS, the Agency hereby requests that the City Council of the City of San Diego [City Council] consider for approval an extension of the initial five (5) year period of time established in Section 33334.16 of the California Health & Safety Code [Code] from October 21, 2005 to October 21, 2009 [Initial Period] and extending the Initial Period an additional five (5) year period from October 21, 2009 to October 21, 2014 [Extended Period]; during which

Extended Period, the Agency shall retain possession of its interest in the Property and initiate

and/or cause the requisite activity necessary for the development of Affordable Housing on the

Property consistent with the statutory requirements of the Section 33334.16 of the Code to take

place; and

WHEREAS, the City Council has received and reviewed the Agency request for approval

of the Extended Period; and

WHEREAS, in connection with such Agency request, the City Council desires to approve

the Extended Period and the Agency's ability to retain possession of its interest in the Property

during the Extended Period consistent with Section 33334.16 of the Code; and

WHEREAS, this activity is not a "project" and is therefore not subject to CEQA pursuant

to State CEQA Guidelines Section 15060(c)(3); NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

The City Council hereby approves the Extended Period and the Agency's ability 1.

to retain possession of its interest in the Property during the Extended Period consistent with

Section 33334.16 of the California Health & Safety Code.

The City Council hereby further affirms its desire and intention that the Agency 2.

develop and/or cause the Property to be developed as Affordable Housing for Qualified Persons

within the Extended Period pursuant to Section 33334.16 of the Code.
