RESOLUTION AUTHORIZING THE ACCEPTANCE AND RECORDATION OF AN EASEMENT DEED, AND COSTS THEREFORE, FOR INSTALLATION OF A RECYCLED WATER PIPELINE AS PART OF THE LOS PENASQUITOS CANYON RECYCLED WATER PROJECT.

WHEREAS, the City of San Diego [City] has a year 2000 Updated Water Reclamation Master Plan [Master Plan]; and

WHEREAS, the proposed Los Penasquitos Canyon Recycled Water Pipeline [Pipeline], identified as "Segment 7" in the Master Plan, is an integral part of City's planned recycled water distribution system in that the Pipeline will ultimately provide up to 1.8 million gallons of recycled water per day to City's Carmel Valley customers; and

WHEREAS, the proposed Pipeline will require the acquisition of easement rights from the County of San Diego which will allow for the installation of necessary pipelines over the County of San Diego's property; said property being located adjacent to the entrance of Canyonside Park on Black Mountain Road; and


WHEREAS, the total estimated cost for acquisition of the easement rights is an amount not to exceed \$18,000, for which funding is available through Water Fund No. 41500, CIP No. 70-954.0 North City Reclamation (Los Penasquitos Canyon Recycled Water Project); NOW, THEREFORE,

BE IT RESOLVED, that the Mayor or his designee, is hereby authorized to take all actions necessary to facilitate the acceptance and recordation of that certain easement deed which conveys to the City those easement rights from the County of San Diego which will allow for the

installation of a recycled water pipeline, as part of CIP No. 70-954.0, North City Reclamation (Los Penasquitos Canyon Water Project).

BE IT FURTHER RESOLVED, that the Comptroller is hereby authorized to expend an amount not to exceed \$18,000 from Water Fund No. 41500, CIP No.70-954.0, North City Reclamation (Los Penasquitos Canyon Water Project), for the acquisition of easement rights, including labor costs, appraisal, title, escrow, and miscellaneous costs associated with the acquisition of easement rights from the County of San Diego in conjunction with the Los Penasquitos Canyon Water Project.
