A RESOLUTION OF THE CITY COUNCIL AUTHORIZING THE MAYOR OR HIS DESIGNEE TO NEGOTIATE AND EXECUTE A CONTRACT FOR EMERGENCY MEDICAL TRANSPORT SERVICES WITH SAN DIEGO MEDICAL SERVICES ENTERPRISE, LLC.

WHEREAS, per the California EMS Act and the Health and Safety Code, the City is required to conduct a competitive procurement process for Emergency Medical Transport Services [EMS]; and;

WHEREAS, the County of San Diego has delegated to the City the responsibility to conduct its own competitive process at periodic intervals; and

WHEREAS, the system currently in place was the result of a competitive process conducted in 1996, which resulted in the selection of the current joint venture, a limited liability partnership between the City of San Diego and Rural/Metro of San Diego, called San Diego Medical Services Enterprise, LLC [SDMSE]; and

WHEREAS, the City drafted and released a Request for Proposal for a new EMS contract on February 20, 2009; and

WHEREAS, SDMSE was selected as the winning proposal and is recommended for an award given its extensive experience, seamless operations, compliance in Citywide response times, and cost effective delivery model; and

WHEREAS, this activity is not a "project" and therefore exempt from California Environmental Quality Act pursuant to the CEQA Guidelines section 15060(c)(3); NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. The Mayor or his designee is authorized to negotiate and execute a contract for and on behalf of the City with SDMSE for Emergency Medical Transport Services, for a period of five years from the date of the fully executed contract, under the terms and conditions set forth in Request for Proposal No. 9560-09-V and SDMSE's Technical and Price Proposals in response thereto. The contract shall have one five-year renewal period contingent on mutual written agreement by the parties, and subject to Council approval by ordinance in accordance with City Charter section 99.

2. The City Attorney is directed to prepare the contract documents in accordance with Request for Proposal No. RFP 9560-09-V and SDMSE's Technical and Price Proposals in response thereto.

3. The City's share of the profits from the contract between the City and SDMSE shall be designated for use by the City's Fire-Rescue Department subject to an annual Fire-Rescue Department needs assessment and Council appropriation.
