A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN INCREASE OF AN AMOUNT UP TO \$220,000 IN THE FISCAL YEAR 2010 CITY PLANNING & COMMUNITY INVESTMENT BUDGET, AUTHORIZING THE COMPTROLLER TO ACCEPT UP TO \$165,000 FROM THE REDEVELOPMENT AGENCY AND \$55,000 FROM THE SAN DIEGO HOUSING COMMISSION INTO THE CITY PLANNING AND COMMUNITY INVESTMENT DEPARTMENT, AND AUTHORIZING FINANCIAL MANAGEMENT TO APPROPRIATE AND THE COMPTROLLER TO EXPEND \$220,000 FROM CITY PLANNING & COMMUNITY INVESTMENT TO COVER THE COST OF AN AFFORDABLE HOUSING PARKING STUDY.

WHEREAS, on August 1, 2007 the City Council Land Use and Housing Committee and the Planning Commission directed staff to 1) revisit current approaches and criteria to parking requirements, 2) bring back recommendations on adjustments to parking ratios related to affordable housing by collecting, analyzing, and justifying data, 3) continue to work on strategies for public parking by identifying policies to maximize street parking, 4) find ways to pro-actively identify shared parking opportunities, 5) investigate alternative parking strategies, 6) move forward with land development code updates related to parking; and


WHEREAS, the City issued a Request for Proposal for Parking Regulation Consultant Services to conduct an Affordable Housing Parking Study [Parking Study]; and

WHEREAS, the proposed cost of the Parking Study is currently estimated at \$220,000; and

WHEREAS, this cost is to be funded through the Redevelopment Agency (\$165,000) and the San Diego Housing Commission (\$55,000); NOW THEREFORE,

1. That it authorizes an increase in an amount up to \$220,000 in the Fiscal Year 2010 City Planning & Community Investment Budget (Fund 100000, Cost Center 1612130013).
2. That it authorizes the Comptroller to accept up to \$165,000 from the Redevelopment Agency and \$55,000 from the San Diego Housing Commission into the City Planning and Community Investment Department (Fund 100000, Cost Center 1612130013).
3. That it authorizes Financial Management, as the designee of the Chief Financial Officer, to appropriate and the Comptroller to expend \$220,000 from the City Planning & Community Investment budget to cover the cost of an Affordable Housing Parking Study.
