A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO TO ADOPT A RESOLUTION TO FORWARD COMMENTS RELATED TO THE DRAFT AIRPORT LAND USE COMPATIBILITY PLANS FOR BROWN FIELD, MONTGOMERY FIELD, AND GILLESPIE FIELD TO THE SAN DIEGO COUNTY REGIONAL AIRPORT AUTHORITY PRIOR TO ITS FINAL ACTION

WHEREAS, on JUL 28 2009 the City Council of the City of San Diego held a public hearing for the purpose of considering draft Airport Land Use Compatibility Plans [ALUCPs] for Brown Field, Montgomery Field, and Gillespie Field, prior to final adoption by the San Diego County Regional Airport Authority [Airport Authority]; and

WHEREAS, the Airport Authority, in its role as Airport Land Use Commission for the County of San Diego, as required by the State of California, is expected to take final action on draft ALUCPs for Brown Field, Montgomery Field, and Gillespie Field in fall 2009; and

WHEREAS, once adopted by the Airport Authority, the draft ALUCPs for Brown Field, Montgomery Field, and Gillespie Field would replace the existing ALUCPs (last revised 2004) for those airports; and

WHEREAS, the proposed draft ALUCP for Brown Field would result in the expansion of the existing airport influence area to include the Otay Mesa, Otay Mesa-Nestor, San Ysidro, and Tijuana River Valley community plan areas within the City of San Diego; and

WHEREAS, the proposed draft ALUCP for Montgomery Field would result in the expansion of the existing airport influence area to include the Clairemont Mesa, College Area, Eastern Area, Kearny Mesa, Kensington-Talmadge, Linda Vista, Mission Valley, Navajo,

Normal Heights, North Park, Serra Mesa, Tierrasanta, University, and Uptown community plan areas within the City of San Diego; and

WHEREAS, the proposed draft ALUCP for Gillespie Field would result in the expansion of the existing airport influence area to include the East Elliott, Navajo, and Tierrasanta community plan areas within the City of San Diego; and

WHEREAS, the Council of the City of San Diego has considered the oral presentations given at the public hearing; and has considered all maps, exhibits, and written documents contained in the file for this project on record in the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the recommendations for revisions expressed by the Council of the City of San Diego during the public hearing, and contained in the Report to City Council, be forwarded to the Airport Authority for consideration prior to final action on the ALUCPs for Brown Field, Montgomery Field, and Gillespie Field.
