DATE OF FINAL PASSAGE

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE, INCLUDING THE CHIEF OF POLICE, TO SUBMIT AN APPLICATION FOR, ACCEPT, EXPEND AND MANAGE THE INTERNET CRIMES AGAINST CHILDREN GRANT FUNDS FOR FISCAL YEARS 2006 AND 2007.

WHEREAS, the City of San Diego [City] was eligible to receive grant funding from the U.S. Department of Justice, Office of Juvenile Justice and Delinquencies Prevention [OJJDP], for the period of 2005 to 2008, for the Internet Crimes Against Children [ICAC] Continuations program; and

WHEREAS, the San Diego Police Department [Department] has an ICAC Unit which utilizes such funding for detective salaries, travel, training, equipment, and consultants from other law enforcement agencies, and educational programs for the community; and

WHEREAS, in Fiscal Year 2006, the ICAC Unit applied for, accepted and expended \$400,000 in OJJDP funds for the above stated purposes; and

WHEREAS, in Fiscal Year 2007, the ICAC Unit applied for, accepted and expended \$550,000 [#2005-MC-CX-K016] of these funds for the above stated purposes; and

WHEREAS, through an oversight, the appropriate resolutions for these actions were not brought to the City Council; and

WHEREAS, the Department now desires to correct that error; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee, including the Chief of Police, be and is hereby authorized and empowered, for and on

behalf of the City, to submit an application for, accept, expend and manage the grant funds and program.

BE IT FURTHER RESOLVED, that this authority includes the execution of all aspects of fund and program operation, including any amendments, extensions, augmentations, additional funding or renewals from OJJDP for identical or closely related purposes; and to certify that the City will comply with all application statutory or regulatory requirements.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept, appropriate and expend these funds up to \$400,000 for Fiscal Year 2006, and \$550,000 for Fiscal Year 2007.

BE IT FURTHER RESOLVED, that this authorization shall be valid for a period of up to five years, covering the period from January 1, 2005 to December 31, 2009 provided that funding for this purpose is made available by OJJDP.

BE IT FURTHER RESOLVED, that any resources received hereunder shall be used to supplement and not to supplant expenditures controlled by this body; and that grant-funded positions are not subject to local hiring freezes.
