A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE SAN DIEGO POLICE DEPARTMENT TO APPLY FOR, ACCEPT, AND EXPEND \$935,628 IN GRANT FUNDS FROM THE U.S. DEPARTMENT OF JUSTICE FOR "PROJECT ALERT AND INTERCEPT."

WHEREAS, the U.S. Department of Justice, under the 2009 Economic Stimulus and Recovery Act, has solicited proposals for Facilitating Justice Information Sharing, Collaboration and Problem Solving; and

WHEREAS, under this solicitation, the San Diego Police Department [SDPD], in collaboration with Automated Regional Justice Information System [ARJIS], wishes to apply for, accept, and expend grant funds in the amount of \$935,628; and

WHEREAS, the project known as "Project Alert and Intercept," if funded, will implement regional alerting technologies to assist in real-time officer notifications for combating narcotics and other multi-jurisdictional crimes; and

WHEREAS, this project will result in the creation of a new technical job position to develop and maintain the alert system; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee, be and is hereby authorized and empowered, for and on behalf of the City, to apply for and take all necessary action to secure funding in the amount of \$935,628 from the 2009 Economic Stimulus and Recovery Act for "Project Alert and Intercept."

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept up to \$935,628 or the actual amount of funding authorized by the U.S. Department of Justice, if the grant funding is secured.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to establish a special interest-bearing fund for the grant funds, if required.


BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend up to \$935,628 or the actual amount of funding authorized by the U.S. Department of Justice, for the purpose of implementing the 2009 Economic Stimulus and Recovery Act grant funds for "Project Alert and Intercept."

BE IT FURTHER RESOLVED, that the Chief of Police is authorized to administer and operate this program, including any amendments, extensions, augmentations, or renewals from the U.S. Department of Justice for identical or closely related purposes; and to certify that the City will comply with all applicable statutory and regulatory requirements.

BE IT FURTHER RESOLVED, that this authorization shall be valid for a period of up to five years, provided funding for this purpose is made available by the U.S. Department of Justice.

BE IT FURTHER RESOLVED, that any resources received hereunder shall be used to supplement and not to supplant expenditures controlled by this body.


