A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO APPLY FOR, ACCEPT, AND EXPEND \$708,238 GRANT MONEY PURSUANT TO THE INTERNET CRIMES AGAINST CHILDREN TASK FORCE GRANT PROGRAM, AMERICAN RECOVERY AND REINVESTMENT ACT PROGRAM, FY 2009.

WHEREAS, the federal government has made grant funding available to law enforcement through the United States Department of Justice for the Internet Crimes Against Children [ICAC] Task Force Program Grant Program as part of the American Recovery and Reinvestment Act [ARRA]; and

WHEREAS, the City of San Diego [City] wishes to apply for, accept, expend such grant money for law enforcement purposes, specifically in support of the San Diego Internet Crimes Against Children [SDICAC] Task Force; and

WHEREAS, the grant money will be used for hiring personnel, including clerical, word processing, and investigate aide support; travelling; purchasing equipment and supplies; upgrading and maintaining the SDICAC network; and

WHEREAS, the City wishes to apply for, accept, and expend \$708,238 in grant money, and to pay for unreimbursable benefit costs of approximately \$110,516 out of the general fund; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to apply for, accept, and expend grant funding up to \$708,238 from the U.S. Dept. of Justice ICAC Grant Program, as part of the FY 2009 ARRA program.


BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to establish a special interest-bearing fund for such funds, if required.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend up to \$708,238 to implement the ICAC Program Grants Program per the FY 2009 ARRA program.

BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to administer and operate this program for a period of up to five years, provided that funding for this purpose is made available by the U.S. Dept. of Justice.

BE IT FURTHER RESOLVED, that any resources received hereunder shall be used to supplement and not to supplant expenditures controlled by this body; and that grant-funded positions are not subject to local hiring freezes.


