A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO APPLY FOR, ACCEPT, AND EXPEND \$6,469,948 TO IMPLEMENT THE JUSTICE ASSISTANCE GRANT 2009, AMERICAN RECOVERY AND REINVESTMENT ACT PROGRAM.

WHEREAS, the U.S. Department of Justice has made grant funding available to law enforcement through the Justice Assistance Grant [JAG] 2009, as part of the American Recovery and Reinvestment Act [ARRA]; and

WHEREAS, the City of San Diego [City] wishes to apply for, accept, expend such grant money for law enforcement purposes as provided in the JAG Program; and

WHEREAS, the JAG Program utilizes an allocation formula for the individual jurisdictions including the County of San Diego [County] and the cities within the County; and

WHEREAS, pursuant to the formula, the total for the County is \$6,469,948, and the City's portion of that total is \$3,062,860; and

WHEREAS, the County and cities within the County must: (1) agree on a fair allocation of the total grant; and (2) have a single applicant/fiscal agent, which is the City; and

WHEREAS, a total of eighteen agencies in the County, including the County, have agreed to participate and receive allocations pursuant to the grant program; and

WHEREAS, the City's portion of unreimbursable benefit costs associated with this grant is approximately \$621,233, to be paid out of the general fund; and

WHEREAS, the City's share will be used by the San Diego Police Department [SDPD] to enhance crime prevention and law enforcement with forensic lab and criminal intelligence personnel hired on a limited basis, with the acquisition of enhanced technology, and with equipment purchases; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to apply for, accept, and expend grant funding under the JAG Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to establish a special interest-bearing fund for such funds, if required.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend up to \$6,469,948 to implement the JAG Program.

BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to enter into interagency agreements to distribute the grant funds as required by the JAG Program.

BE IT FURTHER RESOLVED, upon receipt of the grant funds, the Chief Financial Officer is authorized to make payments to participating agencies pursuant to the terms of the JAG Program.

BE IT FURTHER RESOLVED, that any resources received hereunder shall be used to supplement and not to supplant expenditures controlled by this body; and that grant-funded positions are not subject to local hiring freezes.

BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to administer and operate the JAG Program.

BE IT FURTHER RESOLVED, that this authorization shall be valid for a period of up to five years, covering the period from March 1, 2009 to February 18, 2013, provided that funding for this purpose is made available.
