A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING CITY STAFF TO MAKE FINAL REVISIONS TO THE CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT AND SUBMIT IT TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT.

WHEREAS, the City of San Diego is required to submit a Consolidated Annual Performance and Evaluation Report [CAPER] to the Department of Housing and Urban Development [HUD] at the end of each fiscal year; and

WHEREAS, the CAPER details the City's accomplishments toward meeting the goals, priorities, and objectives outlined in its FY 2005-2009 Consolidated Plan; and

WHEREAS, the CAPER compares the actual performance measures with the performance measures listed in the FY 2009 Action Plan, which is developed before the fiscal year; and

WHEREAS, the CAPER reports on activities funded by Community Development Block Grant [CDBG], HOME Investment Partnership Program [HOME], Emergency Shelter Grant [ESG], Housing Opportunities for Persons with Aids [HOPWA], and American Dream Downpayment Initiative [ADDI] funds; and


WHEREAS, Federal regulations requires that the City provide a period of not less than 15 days to receive public comments on the CAPER and hold a public hearing before the CAPER is submitted to HUD; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego [City Council] that the City has heard and considered all public comments received regarding the CAPER in writing or orally at the public hearing on SEP 21 2009, 2009.

BE IT FURTHER RESOLVED, that City staff is authorized to coordinate final revisions to the CAPER and ensure that public comments received are included in the final draft of the CAPER.

BE IT FURTHER RESOLVED, that City staff is authorized to submit the CAPER to HUD by September 30, 2009 as required by HUD.
