RESOLUTION AUTHORIZING THE EXECUTION AND RECORDATION OF A GRANT OF AN EASEMENT TO SAN DIEGO GAS & ELECTRIC FOR INSTALLATION OF UNDERGROUND AND OVERHEAD ELECTRICAL FACILITIES.

WHEREAS, while performing work on a four-inch steel gas pipeline in the vicinity of the Otay Water Treatment Plant, San Diego Gas & Electric [SDG&E] discovered some cathodic protection interference current on the pipeline; and

WHEREAS, the Salt Creek area near Otay Lakes features an extensive network of San Diego County Water authority, City of San Diego Water Department [City], Otay Water District, and SDG&E pipelines which have lead to the interference current; and

WHEREAS, to mitigate the interference current, a "bond" must be installed between SDG&E's steel gas pipeline and City's rectifiers located within the Otay Water Treatment Plant; and

WHEREAS, the "bond" requires the installation of underground and overhead bond wire from SDG&E's gas pipeline to City's rectifiers; the overhead portion includes placing one new pole between already existing poles and a second pole to extend to the rectifiers and


WHEREAS, to facilitate the installation of the "bond", SDG&E requests an easement from City in order to install the necessary electrical facilities; NOW, THEREFORE,

BE IT RESOLVED, that the Mayor or his designee, is hereby authorized to take all actions necessary to facilitate the execution and recordation of that certain grant of easement

to SDG&E over portions of Lot 4 of Rancho Otay, according to Map thereof No. 862, filed June 4, 1915, and of Lot 2 of Fractional Section 13, Township 18 South, Range 1 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, which will allow for the installation of a "bond" between SDG&E's gas pipeline and City's rectifiers within the Otay Water Treatment Plant facility.


