A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE IMPLEMENTATION PLANS AND BUDGETS FOR THE FY 2010 COMMUNITY PARKING DISTRICT PROGRAM; AUTHORIZING THE CHIEF FINANCIAL OFFICER TO APPROPRIATE AND EXPEND MONEY FROM THE RESPECTIVE COMMUNITY PARKING DISTRICT FUNDS; AND AUTHORIZING THE MAYOR TO EXECUTE SPECIFIED OPERATING AGREEMENTS FOR THE COMMUNITY PARKING DISTRICTS.

WHEREAS, on March 4, 1997, the City Council [Council] adopted Council Policy
No. 100-18 (later amended on November 15, 2005), in which the Council established the
Community Parking District Program, which allows communities, with the approval of the
Council, to implement parking solutions in neighborhoods that face serious parking challenges;
and

WHEREAS, the City currently has six Community Parking Districts located in the following communities: Downtown, Uptown, Mid-City, La Jolla, Old Town, and Pacific Beach; and

WHEREAS, each Community Parking District [CPD] has a designated Advisory Board (with the exception of the Mid-City CPD, which was established with three co-Advisory Boards), responsible for developing an Implementation Plan, managing CPD funds, and fulfilling the community's parking goals as stated in its respective Implementation Plan; and

WHEREAS, CPD funds are dedicated for improvements and activities that increase the availability, supply, and effective use of parking to residents, visitors, and employees in those communities where parking meters are located; and

WHEREAS, pursuant to Council Policy No. 100-18, each CPD is authorized to retain forty-five percent of new parking meter revenues collected within its boundaries; and

WHEREAS, only three of the six existing CPD's (Downtown, Uptown, and Mid-City) currently generate parking meter revenues within their boundaries, and therefore, may retain forty-five percent of the parking meter revenues collected within their respective boundaries; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the FY 2010 Implementation Plans and Budgets for the Downtown, Mid-City, and Uptown Community Parking Districts are hereby approved. A copy of each Plan and Budget is attached to the Executive Summary on file with the Office of the City Clerk.
- 2. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$4,203,490 from the Uptown CPD Fund for the operation of the FY 2010 CPD Program in the Uptown CPD, contingent upon the City Comptroller certification of funds availability. The Uptown CPD Fund will be modified to reflect any expenditure under the FY 2009 agreement incurred but not yet deducted from that Fund, as well as actual parking meter revenues collected in FY 2009.
- 3. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$786,280 from the Mid-City CPD Fund for the operation of the FY 2010 CPD Program in the Mid-City CPD, contingent upon the City Comptroller certification of funds availability. The Mid-City CPD Fund will be modified to reflect any expenditure under the FY 2009 agreement incurred but not yet deducted from that Fund, as well as actual parking meter revenues collected in FY 2009.
- 4. That the Chief Financial Officer is authorized to appropriate an amount not to exceed \$4,945,000 from the Downtown CPD Fund for the operation of the FY 2010 CPD Program in the Downtown CPD, contingent upon the City Comptroller certification of funds availability. The Downtown CPD Fund will be modified to reflect any expenditure under the

FY 2009 agreement incurred but not yet deducted from that Fund, as well as actual parking meter revenues collected in FY 2009.

- 5. That a \$113,844 increase in the Fiscal Year 2010 operating budget for CPD Program Administration is authorized.
- 6. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$113,844 from the CPD Program Administration Costs Fund (200488) for the City's administration of the CPD Program, contingent upon the City Comptroller certification of funds availability.
- 7. That the Mayor or his designee is authorized to execute the FY 2010 Operating Agreements with Uptown Partnership, Inc., El Cajon Boulevard Business Improvement Association, and University Heights Community Development Corporation for the operation of the FY 2010 CPD program in the Uptown and Mid-City Community Parking Districts. The agreements shall incorporate the respective FY 2010 Implementation Plans and Budgets.
