A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF AN INTER-AGENCY INSTRUCTIONAL AGREEMENT WITH THE SAN DIEGO COMMUNITY COLLEGE DISTRICT (MIRAMAR COLLEGE) FOR THE LIFEGUARD TRAINING REIMBURSEMENT PROGRAM.

WHEREAS, the Lifeguard Services Division of the Fire-Rescue Department wishes to enter into an Inter-Agency Instructional Services Agreement [Agreement] with Miramar College, which would allow for the reimbursement to the San Diego Fire-Rescue Department for Lifeguard In-Service training; and

WHEREAS, under the Agreement, Miramar College will reimburse for training provided or received by Lifeguard personnel during regular work hours at a rate of \$2.75 per hour per employee up to a maximum of 240 hours per year; and

WHEREAS, this type of training is conducted during regular work hours and is required to maintain current skills and certification; and

WHEREAS, the agreement mirrors the agreement already in place between the Training Division of the Fire-Rescue Department and Miramar College previously approved by Council on June 12, 2006 [R-2006-1012]; and

WHEREAS, this Agreement will have no fiscal impact to the general fund; and

WHEREAS, the annual Revenue from the program is estimated at \$80,000; and

WHEREAS, the Community College will be invoiced quarterly with the revenue being deposited into a Special Revenue Account set up by the Comptroller; and

WHEREAS, the fund will be drawn based on annual Fire Department spending plan for the use of training and education; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the San Diego Community College District (Miramar College), to implement a Lifeguard Training reimbursement program under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-305319 together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

2. That the City Auditor and Comptroller is hereby authorized to establish a special interest-bearing fund for the sole purpose of enhancing the Lifeguard Training Program.

3. That the City Auditor and Comptroller is authorized to accept, appropriate and expend the revenue for the sole purpose of enhancing the Lifeguard Training Program, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditures are, or will be, on deposit with the City Treasurer.

4. That the City Auditor and Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

BE IT FURTHER RESOLVED, that this activity is not a "project" and is therefore not subject to CEQA pursuant to State CEQA guidelines Section 15060(c)(3).
