A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE FIRST AMENDMENT TO THE CONSULTANT AGREEMENT WITH MOORE, IACOFANO AND GOLTSMAN, INC., FOR THE BARRIO LOGAN COMMUNITY PLAN UPDATE.

WHEREAS, on March 6, 2008, the City of San Diego [City] and Moore, Iacofano and Goltsman [MIG] Planning Consultants [Consultant] entered into an agreement to provide professional planning and mobility services for the development of a new community plan for the Barrio Logan Community Planning Area (on file in the Purchasing & Contracting Department as Agreement No. 8964-08-Z-RFP and on file in the office of the City Clerk as Document No. R-04237); and

WHEREAS, the City and Consultant mutually desire to amend the Agreement for Kimley-Horn and Associates Inc., Consultant's subconsultant, to conduct a supplemental truck traffic evaluation; and

WHEREAS, the community of Barrio Logan faces numerous challenges, including land use conflicts created by an outmoded land use pattern, excessive trucking activity along residential streets and near a school, deficient public facilities and infrastructure, and a lack of affordable housing; and

WHEREAS, the City Planning and Community Investment Department desires to continue to update the Barrio Logan/Harbor 101 Community Plan, Zoning Program and Redevelopment Plan to address these issues; and

WHEREAS, funds are necessary to support the additional truck data collection and analysis work to assist in providing more information for the update; and

WHEREAS, the proposed first amendment is for payment to Consultant in the amount of \$18,000 to provide additional professional services relating to the Barrio Logan Community Plan


Update, and such funds shall be taken from the \$250,000 State of California Environmental Justice Grant previously approved by the City for use in the Barrio Logan Community Plan Update; NOW, THEREFORE,

BE IT RESOLVED, that the First Amendment to the Consultant Agreement with Moore, Iacofano and Goltsman, Inc., for the Barrio Logan Community Plan Update is hereby approved; and

BE IT FURTHER RESOLVED, that the City Chief Financial Officer is hereby authorized to release \$18,000 from Fund No. 6000001–State of California Environmental Justice Grant, to fund the additional truck traffic data collection and analysis to be completed by Kimley-Horn and Associates Inc., subconsultant to the prime Consultant.
