A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A ONE-YEAR EXTENSION OF THE PROJECT AREA COMMITTEE FOR THE CENTRE CITY REDEVELOPMENT PROJECT.

WHEREAS, on September 11, 1990, the Council of the City of San Diego [Council], by Resolution No. R-276511, adopted the Procedures for the Formation of a Project Area Committee [PAC] for the Centre City Redevelopment Project [Project], and has subsequently adopted certain amendments to such Procedures; and

WHEREAS, on November 6, 2001, the Council, by Resolution No. R-295698, established the Centre City Advisory Committee [CCAC] and approved the CCAC Bylaws, and such Bylaws have been subsequently amended by the CCAC and the PAC; and

WHEREAS, in order to expand opportunities for citizen participation, the CCAC membership consists of all of the PAC members and three additional representatives from areas within the Centre City Community Plan area; and

WHEREAS, in accordance with the CCAC Bylaws, the CCAC and the PAC function as concurrent operating committees, and votes are tallied and reported separately for the CCAC and the PAC; and

WHEREAS, California Community Redevelopment Law requires that PACs remain in existence for three years from the date of adoption of the redevelopment plan and are thereafter subject to one-year extensions by the legislative body (i.e., the Council); and

WHEREAS, the Council previously has approved multiple one-year extensions of the PAC for the Project, and the PAC is presently authorized to remain in operation through October 31, 2009; and

WHEREAS, the PAC continues to be a valuable advisory committee to the Redevelopment Agency of the City of San Diego, which administers the Project through the Centre City Development Corporation; NOW, THEREFORE,

BE IT RESOLVED, by the Council, as follows:

That the Council hereby approves a one-year extension, from November 1, 2009, through October 31, 2010, regarding the operation of the Project Area Committee for the Centre City Redevelopment Project.
