A RESOLUTION OF COUNCIL OF THE CITY OF SAN DIEGO (i) AMENDING THE FISCAL YEAR 2010 CAPITAL IMPROVEMENT PROGRAM BUDGET FOR CIP NO. S-10050 BY INCREASING THE BUDGET AMOUNT BY \$250,000; FOR THE PURPOSE OF FUNDING THE DESIGN AND CONSTRUCTION OF NEW STREETSCAPE IMPROVEMENTS WITHIN THE NORTH PARK REDEVELOPMENT PROJECT AREA; AND (ii) AUTHORIZING THE RETURN TO THE AGENCY OF ANY AND ALL FUNDS FROM THIS ALLOCATION REMAINING IN FUND NUMBER 10272 IF THERE ARE ANY COST SAVINGS.

WHEREAS, the Redevelopment Agency of the City of San Diego [Agency] is engaged in activities necessary to carry out and implement the Redevelopment Plan for the North Park Redevelopment Project Area [Project Area]; and

WHEREAS, in order to implement the Redevelopment Plan for the Project Area, the Agency approved the Third 5-Year Implementation Plan for the period of Fiscal Years 2008 through 2012 [Third Implementation Plan]; and

WHEREAS, the Redevelopment Plan and the Third Implementation Plan identify the need for the construction of streetscape improvements to eliminate blighting conditions; and

WHEREAS, the Agency now proposes to contribute up to \$125,000 from the Project Area's tax increment funds as an increase in the Fiscal Year 2010 Capital Improvement Program [CIP] Budget in CIP No. S-10050, North Park Mini-Park and Streetscape Improvements, Fund No. 200356, RDA Contributions – NP, to pay for the cost of design and construction of certain streetscape improvements [Improvements], which will help improve the area located adjacent to a public park consisting of approximately one-half acre to be developed potentially in the future, often referred to as the future North Park Mini-Park; and

WHEREAS, the Agency desires to pay for the cost of the Improvements to implement the goals and objectives of the Redevelopment Plan and the Third Implementation Plan because the City presently has insufficient funding for the Improvements; and

WHEREAS, the City will manage the design and construction of the Improvements in connection with the City's existing CIP project known as the North Park Mini-Park and Streetscape Improvements Project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. That the Mayor, or designees, is authorized to take all necessary actions to secure funding from the Agency to be used toward cost of the Improvements.
- 2. That the Chief Financial Officer is authorized to accept an amount not to exceed \$125,000 from the Agency, into Fund Number 200356, RDA Contributions NP, for a Streetscape Master Plan for the North Park Mini-Park within the North Park Redevelopment Project Area.
- 3. That the Council hereby amends the Fiscal Year 2010 Capital Improvement Program Budget by adding CIP No. S-10050, North Park Mini-Park and Streetscape Improvements.
- 4. That the Council hereby amends the Fiscal Year 2010 Capital Improvement Program Budget for CIP No. S-10050, North Park Mini-Park and Streetscape Improvements, Fund No. 200356, RDA Contributions NP, by increasing the budget by \$125,000.
- 5. That the Chief Financial Officer is authorized to appropriate and expend \$125,000 from CIP No. S-10050, North Park Mini-Park and Streetscape Improvements, Fund No. 200356, RDA Contributions-NP, for the purpose of creating a Streetscape Master Plan for the project upon certification of funds.

6. That the Council hereby amends the Fiscal Year 2010 Capital Improvement Program Budget for CIP No. S-10050, North Park Mini-Park and Streetscape Improvements, Fund No.400110, Park North-East Park Development Fund, by increasing the budget by

7. That the Chief Financial Officer is authorized to appropriate and expend \$125,000 from CIP No. S-10050, North Park Mini-Park and Streetscape Improvements, Fund No.400110, Park North-East Park Development Fund, for the purpose of creating a North Park Mini-Park General Development Plan for the project, upon certification of funds.

8. That the Chief Financial Officer is authorized to transfer back to the Agency any and all funds remaining in the Capital Improvement Program Budget in CIP No. S-10050, North Park Mini-Park and Streetscape Improvements, Fund No. 200356, RDA Contributions – NP, upon any cost savings should actual costs of designing the Streetscape Master Plan be less than \$125,000.
