A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPOINTING CITIZENS TO THE CITIZENS'
REVENUE REVIEW AND ECONOMIC COMPETITIVENESS
COMMISSION

WHEREAS, the City Council approved the FY 2010 Fiscal Reform in June 2009, which included the establishment of the Citizens' Revenue Review and Economic Competitiveness Commission [Commission] under the City of San Diego's Budget and Finance Committee; and

WHEREAS, on September 23, 2009, the Budget and Finance Committee approved establishing the Commission, with its membership outlined as stated in the memorandum by Councilmember Tony Young dated September 21, 2009; and

WHEREAS, on October 13, 2009, the Council approved creation of the Commission pursuant to Charter section 43(b); and

WHEREAS, the purpose of the Commission is to engage the public and private sectors in reviewing best practices and strategies designed to retain businesses in San Diego and make recommendations towards providing efficient, effective and quality city services; and

WHEREAS, the Commission will also research strategies to maximize City revenues that are spent for the City's core function of services including neighborhood infrastructure improvements, libraries, park and recreation, and public safety, and make recommendations to the Mayor and Council for their review and consideration; and

WHEREAS, the nine-member Commission is to be composed of one appointee by each Councilmember and one appointee by the Mayor; and

WHEREAS, each Councilmember has submitted a nominee for appointment by the Council; and

WHEREAS, the Mayor has submitted an appointment for confirmation by the Council;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that Council hereby makes the following appointments to the Citizens' Revenue Review and Economic Competitiveness Commission:

District 3 – Robert Nelson

District 4 – Roque Barros

District 5 – Ted Bonanno


District 6 – Stephen Standifird

District 7 – Alan Gin

District 8 – Gangaram Singh

BE IT FURTHER RESOLVED, that the District 2 nominate and the Mayor's appointee will be submitted to the Council for appointment and confirmation at which time the Commission will be authorized to begin meeting.
