A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ESTABLISHMENT OF A CAPITAL IMPROVEMENT PROGRAM [CIP] FOR BUS STOP IMPROVEMENTS

WHEREAS, on July 29, 2008, by Resolution R-304026, the City of San Diego entered into an agreement with MTS whereby the City receives a portion of the revenues from advertising on bus benches and bus shelters within the City; and

WHEREAS, under the agreement with MTS, the use of these funds is limited to capital improvements within the vicinity of MTS bus stops; NOW THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the Chief Financial Officer is authorized to establish a special interest bearing fund, "Bus Stop Capital Improvement," for revenue from the bus bench and bus shelter advertising program; and
2. That the Chief Financial Officer is authorized to transfer \$154,811.86 from fund 400264, PRIVATE & OTHERS CONTRIB-CIP, to newly established interest bearing fund, Bus Stop Capital Improvement, for the purpose of capital improvements in support of bus stops; and
3. That the addition of CIP #A-ID.00007, "Annual Allocation-Bus Stop Improvements", to the Fiscal Year 2010 Capital Improvements Program is authorized; and
4. That an increase in the amount of \$154,811.86 to the Fiscal Year 2010 Capital Improvements Program Budget in CIP #A-ID.00007, "Annual Allocation-Bus Stop

Improvements”, special interest-bearing fund “Bus Stop Capital Improvement”, is authorized;  
and

5. That the Chief Financial Officer is authorized to appropriate and expend \$154,811.86 from CIP #A-ID.00007, “Annual Allocation-Bus Stop Improvements”, special interest-bearing fund “Bus Stop Improvement”, for the purpose of capital improvements in support of bus stops.
