A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE ELECTION RESULTS OF OCTOBER 26 AND 27, 2009, FOR THE CENTRE CITY REDEVELOPMENT PROJECT AREA COMMITTEE AND CENTRE CITY ADVISORY COMMITTEE.

WHEREAS, on September 11, 1990, the City Council of the City of San Diego [Council], by Resolution No. R-276511, adopted the Procedures for the Formation of a Project Area Committee [PAC] for the Centre City Redevelopment Project [Project], and has subsequently adopted certain amendments to said procedures [collectively, Procedures]; and

WHEREAS, on November 6, 2001, the Council, by Resolution No. R-295698, established the Centre City Advisory Committee [CCAC] and approved the CCAC Bylaws, which said bylaws have been subsequently amended by the CCAC and PAC [Bylaws]; and

WHEREAS, in order to expand opportunities for citizen participation, the CCAC membership consists of all of the PAC members and three additional representatives from areas within the Centre City Community Plan area; and

WHEREAS, in accordance with the CCAC Bylaws, the CCAC and the PAC function as concurrent operating committees, and votes are tallied and reported separately for the CCAC and the PAC; and

WHEREAS, California Community Redevelopment Law requires that PACs remain in existence for three years from the date of adoption of the redevelopment plan and are thereafter subject to one-year extensions by the legislative body (i.e., the Council); and

WHEREAS, at its meeting on October 27, 2009, the Council adopted Resolution No. R-305353, which approved a one-year extension of the PAC for the Project, and said resolution became effective upon the Mayor's approval on November 12, 2009; and

WHEREAS, the annual PAC and CCAC election was conducted on October 26, 2009 and October 27, 2009, after notice and in accordance with the Procedures of the PAC, the Bylaws of the CCAC and PAC, and applicable law; and

WHEREAS, a representative from the City Clerk's Office attended the annual election to ensure its validity and provide official verification of the tallying of ballots; and

WHEREAS, the newly elected members of the PAC have submitted information establishing the qualifications and eligibility of each member relative to district, category or organization as appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That the Project Area Committee [PAC] for the Centre City Redevelopment Project and the Centre City Advisory Committee [CCAC], including those persons who received the highest number of votes in their respective categories and listed on the City Clerk's Office's verification of election results attached hereto as Attachment "A" and incorporated herein by this reference, are hereby approved as constituting a representative PAC and CCAC.
