

ORDINANCE NUMBER O- 19950 (NEW SERIES)  
DATE OF FINAL PASSAGE MAY 11 2010

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING TO EXECUTE THE FIRST AMENDMENT TO AN AGREEMENT WITH ROSELING NAKAMURA TERADA ARCHITECTS, INC. FOR THE LA JOLLA COVE LIFEGUARD STATION IN THE LA JOLLA COMMUNITY PLAN AREA.

WHEREAS, in May 2008, City Council approved approximately \$102.2 million of financing for deferred projects throughout the City; and

WHEREAS, in March 2009, the City executed the financing and received the deferred maintenance bond proceeds; and

WHEREAS, on July 28, 2009, the updated list of deferred maintenance projects was approved by City Council and the list included funds for design completion and construction of the La Jolla Cove Lifeguard Station; and

WHEREAS, Roseling Nakamura Terada Architects, Inc. was selected in accordance with Council Policy 300-7, and entered into an agreement with the City of San Diego on October 14, 2002, as Document No. C-11638; and

WHEREAS, the proposed first amendment to the agreement with Roseling Nakamura Terada Architects, Inc. is required to update the plans in order to meet the current code, design an accessible ramp, finalize the plans and specifications, provide support during construction and to provide as-built drawings; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor be and he is hereby authorized and empowered to execute, for and on behalf of said City, the first amendment to an agreement with Roseling Nakamura Terada Architects, Inc, for the purpose of completing the design phase of the La Jolla Cove Lifeguard

Lifeguard Station the under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. OO 19950, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

Section 2. That the expenditure of an amount not to exceed \$75,000 from CIP No. S-00792, La Jolla Cove Lifeguard Station, is authorized for the purpose of providing funds for the above referenced Project.


Section 3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 4. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been available to the City Council and the public a day prior to its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
