DATE OF FINAL PASSAGE MAY 18 2010

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A THIRD AMENDMENT TO AN AGREEMENT WITH HALE ENGINEERING & SURVEYING, INC. FOR THE SCRIPPS RANCH/MIRA MESA BOULEVARD MEDIANS PROJECT.

WHEREAS, Hale Engineering & Surveying, Inc. was retained on June 24, 2004 to provide engineering services related to the improvement of medians on Scripps Ranch Boulevard from Interstate 15 to Scripps Ranch Boulevard; and

WHEREAS, on December 17, 2007, a First Amendment was executed by the City to add bike lanes and signal improvements to the project; and

WHEREAS, on January 29, 2009, a Second Amendment was executed by the City to make design changes needed to accommodate conflicts with a utilities undergrounding project along Scripps Ranch Boulevard; and

WHEREAS, it has been more than five years since the original agreement with Hale Engineering & Surveying, Inc. was executed, and thus City Charter section 99 requires an ordinance of the San Diego City Council to authorize the extension of this agreement; and

WHEREAS, the City and Hale Engineering & Surveying, Inc. now desire to extend the termination date of this agreement until March 31, 2012; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Hale Engineering & Surveying, Inc.

for professional engineering services for WBS S-00838 (Legacy CIP 52-358.0), the Scripps Ranch/Mira Mesa Boulevard Medians Project [Project] under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. OO **19953**

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been available to the City Council and the public a day prior to its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
