

ORDINANCE NUMBER O- 19992 (NEW SERIES)

DATE OF FINAL PASSAGE SEP 14 2010

AN ORDINANCE TO EXECUTE A FIRST AMENDMENT TO A PARTICIPATION AGREEMENT FOR A TIME EXTENSION WITH PARDEE HOMES, A CALIFORNIA CORPORATION, FOR THE DESIGN AND CONSTRUCTION OF PACIFIC HIGHLANDS RANCH RECLAIMED WATER PIPELINES.

WHEREAS, City Council of the City of San Diego approved the original Participation Agreement for Design and Construction of the Pacific Highlands Ranch Reclaimed Water Pipeline on October 10, 2005, Resolution R-300906 with Pardee Homes, a California Corporation in the amount not to exceed \$1,448,345, and in the form on file in the office of the City Clerk as Document No. RR-300906; and

WHEREAS, Pardee Homes needs a time extension for the design and construction of the Pacific Highlands Ranch Reclaimed Water Pipeline; NOW THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute a First Amendment to the existing agreement with Pardee Homes, a California Corporation, for the design and construction of Pacific Highlands Ranch Reclaimed Water Pipelines, extending the agreement for five (5) additional years.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been available to the City Council and the public a day prior to its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
