AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO AN AGREEMENT WITH NADEL ARCHITECTS, INC. FOR THE DESIGN OF POINT LOMA FIRE STATION NO. 22.

WHEREAS, Point Loma Fire Station No. 22 is a 67-year old facility servicing the Point Loma area; and

WHEREAS, this project includes the and design of a new facility; and
WHEREAS, Nadel Architects, Inc. was selected in accordance with Council
Policy 300-7, and entered into an agreement with the City of San Diego on March 9, 2004, as
Document No. C-12599; the original total amount of the original agreement was \$249,900; and

WHEREAS, the plans for the project were developed to approximately sixty percent completion with input from the community and Fire Rescue personnel; and

WHEREAS, the proposed amendment to the Agreement with Nadel Architects, Inc. is required to update the plans to meet the current code, to comply with the new LEED requirements, and finish the plans and specifications for the project; and

WHEREAS, funds are now available to complete the design of the project; and

WHEREAS, under Charter Section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of said City, a First Amendment to an Agreement with Nadel Architects, Inc. for the purpose of completing the design for the Point Loma Fire Station No. 22 [Project] under the terms and conditions set forth in the First Amendment to the Agreement, on file in the office of the City Clerk as Document No. OO _____1994

Section 2. That the expenditure of an amount not to exceed \$160,100 from CIP No. S-00787, Point Loma Fire Station No. 22, is authorized for the purpose of executing this First Amendment to the Agreement, contingent upon the City Comptroller first certifying funds are available providing funds for the above referenced Project and contingent upon approval of the Fiscal Year 2011 Appropriation Ordinance.

Section 3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 4. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been available to the City Council and the public a day prior to its passage.



Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
