AN ORDINANCE AMENDING ORDINANCE NO. O-19952 (NEW SERIES) ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 2011

WHEREAS, the City Council adopted Ordinance No. O-19952 on May 4, 2010, an Ordinance of the City of San Diego Establishing A Schedule of Compensation For Officers and Employees of the City of San Diego For The Fiscal Year 2011 (herein "FY 2011 Salary Ordinance"); and

WHEREAS, the City Council adopted Ordinance No. O-19986 on August 4, 2010 (the date of final passage is recorded as August 5, 2010), one condition of which is the elimination of retirement offsets for elected officials and City employees not represented by a labor organization; and

WHEREAS, this Ordinance has been prepared in order to amend Ordinance No. O-19952, the FY 2011 Salary Ordinance, in order to adjust the Retirement Contribution Rates in Section 14 thereof;

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the FY 2011 Salary Ordinance is hereby amended to authorize the following adjustments to the Retirement Contribution Rates in Section 14:

Section 2. That a full reading of this Ordinance is dispensed with prior to passage, since a written copy was made available to the City Council and the public prior to the day of its passage.




