DATE OF FINAL PASSAGE

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVENG THE GRANT APPLICATION SUBMITTAL FOR THE EDUCATIONAL EXHIBITS AND IMPROVEMENTS TO THE OTAY VALLEY REGIONAL PARK.

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his representative is authorized to make an application to the State of California for an amount not to exceed \$304,500 in Nature Education Facilities Program grant funds for the design, construction, and installation of bilingual interpretive panels, and benches/sitting rocks in the Otay Valley Regional Park (Project).

Section 2. That the Mayor or his representative is authorized to conduct all negotiations, sign and submit all documents, including, but not limited to applications, agreements, amendments, and payment requests, which may be necessary for the completion of the Project.

Section 3. That the Chief Financial Officer is authorized to accept, appropriate, and expend funds if grant funding is secured.

Section 4. That the Chief Financial Officer is authorized to establish a special interest bearing account for the grant funds.

Section 5. That the City certifies it will have sufficient funds available to complete the Project, prior to commencement of any work on the Project included in the application, should the grant be awarded.

Section 6. That the City certifies it will have sufficient funds to operate and maintain the Project.

Section 7. That the City certifies it has reviewed, understands, and agrees to the General Provisions contained in the contract shown in the Grant Administration Guide.

Section 8. That the City agrees to comply with all applicable federal, state, and local laws, ordinances, rules, regulations, and guidelines in the execution of the grant agreement.

Section 9. That the City certifies the Project is consistent with the City of San Diego General Plan, Otay Valley Regional Park Concept Plan, and all other applicable planning documents.

Section 10. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been available to the City Council and the public prior to the day of its passage.

Section 11. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
