AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO AN AGREEMENT WITH DOMINY + ASSOCIATES ARCHITECTS @ DOMUSSTUDIO LLP, FOR THE SOUTH MISSION BEACH LIFEGUARD STATION.

WHEREAS, the existing South Mission Beach Lifeguard Station was built in the early 1970's as a temporary lifeguard tower and now it is undersized, deteriorated and no longer serves the needs of the lifeguard staff nor the beach going public; and

WHEREAS, the proposed project will design a new facility with an observation tower, first aid room, male/female locker rooms, second observation area and ambulance/rescue vehicle access right next to the proposed lifeguard station; and

WHEREAS, the firm Dominy + Associates Architects @ domusstudio LLP was selected in accordance with Council Policy 300-7, and entered into an agreement with the City of San Diego on September 24, 2003, Document No. C-12257; and

WHEREAS, the total amount of the preliminary phase of this agreement was set at \$122,420; and

WHEREAS, the proposed First Amendment to the Agreement is required to update the plans in order to meet the current code, finalize the plans and specifications, provide support during construction and provide as-built drawings; and

WHEREAS, under Charter Section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of said City, a First Amendment to an Agreement with Dominy + Associates Architects @ domusstudio LLP, for the purpose of completing the design phase for the South Mission Beach Lifeguard Station [Project] in the amount of \$100,000, under the terms and conditions set forth in the First Amendment to the Agreement on file in the office of the City Clerk as Document No. OO \_\_\_\_\_\_\_.

Section 2. That the expenditure of an amount not to exceed \$100,000 from CIP No. S-00791, South Mission Beach Lifeguard Station, Fund 400624, Deferred Maintenance Bond – 2009, is authorized for the purpose of executing this First Amendment to the Agreement, contingent upon the City Comptroller first certifying funds are available providing funds for the above referenced Project.

Section 3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 4. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been available to the City Council and the public a day prior to its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
