A RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING AN AS-NEEDED CONSULTING AGREEMENT WITH MWH AMERICAS, INC. FOR MISSION BAY LANDFILL REGULATORY COMPLIANCE REPORTING.

WHEREAS, state law requires the City to periodically sample, analyze, and report on groundwater conditions at the Mission Bay Landfill, which requires the technical services of an environmental consultant; and

WHEREAS, the City conducted a competitive process to procure these consulting services in accordance with Administrative Regulation 25.60 and Council Policy 300-7, and MWH Americas, Inc., was chosen, subject to Council approval; and

WHEREAS, on December 9, 2009, the Natural Resources & Culture Committee heard this item and recommended forwarding it to the full City Council for approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, an agreement with MWH Americas, Inc., for as-needed consulting services in connection with Mission Bay Landfill regulatory compliance reporting, under the terms and conditions set forth in the Agreement Between the City of San Diego and MWH Americas, Inc. for As-Needed Consultant Services for Mission Bay Regulatory Compliance Reporting, on file with the City Clerk as Document No. RR- 305513

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$240,000 from Fund No. 700039 Refuse

Disposal Enterprise, General Ledger Account 512059, Business Area 2115, Cost Center 2115121212, solely and exclusively to provide funds for the above agreement.

BE IT FURTHER RESOLVED, that the City Comptroller is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.
