A RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING AN INCREASE IN THE FY10 CIP BUDGET FOR JOINT USE IMPROVEMENTS TO THE LANGUAGE ACADEMY/ MONTEZUMA ELEMENTARY SCHOOL.

WHEREAS, the Language Academy/Montezuma Elementary School Joint Use
Improvement project [Project] provides for the design and construction of approximately 1.37
acres at the Language Academy (formerly Montezuma Elementary School) for joint use facilities
to supplement existing park acreage in the College Area community; and

WHEREAS, \$215,000 out of the Navajo DIF Fund No. 400116 (legacy 079506) was incorrectly appropriated into the Language Academy/Montezuma Elementary School Joint Use Improvement project in the FY09 CIP Budget. The correct appropriation should have been \$215,627.77 out of the College Area DIF Fund No. 400127 (legacy 079519).

WHEREAS, because the project is located in the College Area community, it is more appropriate to fund the project with College Area DIF funds.

WHEREAS, this council action aims to correct the appropriation by deappropriating the \$215,000 of Navajo DIF from the project and appropriating \$215,627.77 from the College Area DIF into the Project; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego:

1. That the Chief Financial Officer, as delegated to Financial Management, is authorized to increase the FY10 CIP Budget in S-00972, Language Academy/Montezuma

(R-2010-387)

Elementary School – Joint Use Improvements, in Fund No. 400127, College Area DIF, by

\$215,627.77 contingent upon City Comptroller certification that funds are available.

2. That the Chief Financial Officer, as delegated to Financial Management, is hereby

authorized to appropriate and the City Comptroller to expend funding in the amount of

\$215,627.77 from CIP S-00972, Language Academy/Montezuma Elementary School – Joint Use

Improvements Fund 400127, College Area DIF, fund balance to reconcile an incorrect

appropriation.

3. That the Chief Financial Officer, as delegated to Financial Management is

authorized to deappropriate \$215,000 in Fund 400116, Navajo DIF, CIP S-00972, Language

Academy/Montezuma Elementary School – Joint Use Improvements, and to return \$215,000 to

Fund 400116, Navajo DIF, fund balance to reconcile an incorrect appropriation.

4. That the City Comptroller, upon advice from the administering department, is

authorized to transfer excess funds, if any, to the appropriate reserves.
