A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING PAYMENT FOR EXPERT SERVICES RENDERED IN LITIGATION IN THE CASE OF *MARCUS R. ABBE, ET AL. V. CITY OF SAN DIEGO,* USDC CASE NO. 05CV1629 DMS [SDPOA #2]

WHEREAS, on August 16, 2005, current and former San Diego Police Department officers filed a lawsuit against the City in the case of *Marcus R. Abbe*, *et al. v. City of San Diego*, USDC Case No. 05cv1629 DMS [SDPOA #2]. The case was consolidated by the United States District Court with a related case, *Brett H. Burkett*, *et al. v. City of San Diego*, USDC Case No. 06cv538 DMS. There are approximately 1500 Plaintiffs; and

WHEREAS, the City, through its outside counsel, engaged LECG LLC and Wildan Homeland Solutions to provide expert services in conjunction with the jury trial that resulted in a final judgment in favor of the City; and

WHEREAS, LECG LLC has requested payment for expert services in the amount of \$368,733.71 and Wildan Homeland Solutions has requested payment for expert services in the amount of \$15,129.00 for a grand total for such expert services in the amount of \$383,862.71; NOW THEREFORE,

BE IT RESOLVED that the City's Chief Financial Officer is authorized to expend an amount not to exceed \$368,733.71 from the Public Liability Fund, solely, and exclusively for the purpose of providing funds for the expert services rendered by LECG LLC incurred in the SDPOA #2 litigation.

BE IT FURTHER RESOLVED that the City's Chief Financial Officer is authorized to expend an additional amount not to exceed \$15,129.00 from the Public Liability Fund, solely, and exclusively for the purpose of providing funds for the expert services rendered by Wildan Homeland Solutions incurred in the SDPOA #2 litigation.
