A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING APPOINTMENTS TO THE SOLID WASTE LOCAL ENFORCEMENT AGENCY HEARING PANEL.

WHEREAS, the City of San Diego was designated its own solid waste Local Enforcement Agency (LEA) by the California Integrated Waste Management Board on November 19, 1997; and

WHEREAS, the LEA is charged with enforcing state regulations related to solid waste facilities, such as those regarding inspections, permitting and other enforcement activities; and

WHEREAS, California Public Resources Code section 44308 provides that a hearing panel shall be appointed to conduct an appeal hearing in the event an LEA action is appealed; and

WHEREAS, the Solid Waste Local Enforcement Agency Hearing Panel (the Solid Waste LEA Hearing Panel) consists of three members, who shall be selected for their legal, administrative or technical abilities in areas related to solid waste management; and

WHEREAS, at least one member shall be a technical expert, at least one member shall be a representative of the public at large, and no more than one member of the governing body may serve on the hearing panel; and

WHEREAS, members shall serve for a term of four years and may not serve more than two consecutive terms; and

WHEREAS, the chairperson of the governing body, the Council President, shall appoint the three members to the Solid Waste LEA Hearing Panel, subject to confirmation by a majority vote of the City Council; and

WHEREAS, Council President Ben Hueso has appointed Elmer Heap, as a legal expert, and Daniel Avera, as a technical expert, to the panel, subject to Council confirmation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments by the Council of the City of San Diego to serve as members of the Solid Waste Local Enforcement Agency Hearing Panel, are and the same are hereby confirmed:
