A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING APPOINTMENTS TO THE STANDING COMMITTEES FOR CALENDAR YEAR 2010.

WHEREAS, San Diego Charter section 270(d) provides that the City Council shall have the right to determine its own rules and order of business; and

WHEREAS, Rule 6.1 of the Permanent Rules of the City Council, San Diego Municipal Code section 22.0101.5, provides that there shall be six standing committees of the City Council; and

WHEREAS, Rule 6.2.1 provides that, for each committee, except for the Committee on Rules, Open Government, and Intergovernmental Relations (Rules Committee), the Council President shall, no later than the second meeting of the Council in January of each year, nominate the committee Chair, vice-chair, and committee members, subject to confirmation by a majority vote of the City Council; and

WHEREAS, Rule 6.11.1 states that the Council President shall serve as the Chair of the Rules Committee and that the Council President Pro Tem shall serve as the Vice-Chair; and

WHEREAS, the City Council has selected Councilmember Ben Hueso to serve as Council President for a second term, which commenced on December 7, 2009; and

WHEREAS, the Council President has submitted nominations for each committee Chair, vice-chair, and committee members, for a term commencing on January 1, 2010; and

WHEREAS, under Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not

affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to section 22.0101.5 of the Municipal Code of the City of San Diego, the following appointments by the Council President to serve as Chairs, vice-chairs, and committee members of the following standing Council committees for terms commencing January 1, 2010, and lasting for one year and until a successor is duly appointed and confirmed, are and are hereby confirmed:
