DATE OF FINAL PASSAGE JAN 22 2010

A RESOLUTION AUTHORIZING THE MAYOR, OR HIS  
DESIGNEE, TO EXECUTE AN EASEMENT IN FAVOR OF  
SAN DIEGO GAS & ELECTRIC AFFECTING PORTIONS OF  
PARCEL 2 OF PARCEL MAP NO. 14492.

WHEREAS, easement rights will allow San Diego Gas & Electric [SDG&E] to install  
and maintain overhead electrical service to City owned property; and

WHEREAS, the proposed easement will allow SDG&E to erect, construct, modify,  
improve, reconstruct, relocate, repair, maintain and use facilities consisting of poles, wires,  
cables and appurtenances for the transmission and distribution of electricity and related electrical  
purposes; and

WHEREAS, the overhead electrical lines will be attached to existing poles which are  
located at the dead end of unimproved land (currently being used as a recycling area); and


WHEREAS, SDG&E is seeking an overhead easement because they could not find an  
easement on the existing pole; and

WHEREAS, since the electrical facilities will benefit City of San Diego property, the  
easement rights are to be granted to SDG&E at no cost. SDG&E shall be responsible for any and  
all costs; and

WHEREAS, this agreement is not subject to the City's Equal Opportunity Contracting  
(San Diego Ordinance No. 18173, section 22.2701 through 22.2708; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor, or his designee, is authorized and empowered to execute, for and on behalf of The City of San Diego, an easement deed conveying to San Diego Gas & Electric Company, a corporation, an easement in favor of SDG&E affecting portions of Parcel 2 of Parcel Map No. 14492, filed September 30, 1986 at File No. 86-436975 in the Office of the County Recorder of said County of San Diego, as more particularly described in said easement deed on file in the office of the City Clerk as Document No. RR- 305549.
