

RESOLUTION NUMBER R- 305570
DATE OF FINAL PASSAGE FEB 04 2010

WHEREAS, the San Diego City Council adopted an ordinance, codified at San Diego Municipal Code section 26.16, establishing the Citizens Equal Opportunity Commission [Commission]; and

WHEREAS, the Commission is responsible for monitoring and/or evaluating the City's Equal Opportunity Program; advising the Mayor, City Council, Civil Service Commission and other appropriate agencies; submitting written quarterly reports for review by the City Council's Rules Committee and City Council; assisting in recruiting competent, historically under-represented minorities, women and disabled to compete for City positions; and promoting the City of San Diego as an Equal Opportunity Employer of individuals and firms desiring to contract with the City; and

WHEREAS, the Commission consists of eleven members who are appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the Commission includes one representative from each of the following historically under-represented groups: Latino, African-American, Filipino, American Indian, Asian/Pacific Islander, Disabled, and Lesbian/Gay/Bisexual/Transgender [LGBT]; and

WHEREAS, the four remaining representatives are appointed from the City-at-large; and

WHEREAS, Commissioners serve two-year terms and serve until a successor is duly appointed and confirmed; and


WHEREAS, Commissioners are appointed so that the terms of not more than six (6) members will expire in any year and the expiration date of all terms is January 1; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following reappointments by the Mayor of the City of San Diego to serve as members of the Commission, for a term ending as indicated, are hereby confirmed:

BE IT FURTHER RESOLVED, that pursuant to Council Policy 000-13, for purposes of deliberation and consideration of reappointment, it is determined that Maurice Wilson is a resident of San Diego County, but not the City of San Diego, and has unique qualifications to serve as a member of the Commission; therefore, a conscious exception to Council Policy 000-13 is hereby declared.
