A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING TO RENEW AN AGREEMENT WITH KONICA MINOLTA BUSINESS SOLUTIONS FOR RENTAL CONVENIENCE COPIERS PROGRAM.

WHEREAS, the Publishing Services Division administers the Citywide contract for the provision of approximately 600 office copiers; and

WHEREAS, the City Council approved Resolution No. R-300650 on July 18, 2005, authorizing Konica Minolta Business Services to provide rental convenience copiers as required for a period of three years with options to renew the contract for two additional one year periods; and

WHEREAS, the copiers were placed into service in August 2006; and
WHEREAS, annual expenditures are based on actual utilization of the machines in
various City operations and are not expected to exceed \$2.3M; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his designee is hereby authorized and empowered to exercise, a one-year option for the period of August 23, 2009 to August 22, 2010 for and on behalf of said City with Konica Minolta Solutions, to provide rental convenience copiers, in an amount not to exceed \$2,300,000, under the terms and conditions set forth in the Agreement (Request for Proposal No. 6681-04-T-RFP) on file in the office of the City Clerk as Document No. RR 305651.

- 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$2,300,000 from Fund No. 720041, solely and exclusively for the purpose of providing funds for the Project, provided that the Chief Financial Officer first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.
- 4. That this item be referred to the Budget and Finance Committee for further discussion and review.
