A RESOLUTION OF THE CITY COUNCIL AUTHORIZING THE CITY'S COST SHARE EXPENDITURES FOR THE REGIONAL STORM WATER PERMIT UNDER THE MEMORANDUM OF UNDERSTANDING WITH OTHER COPERMITTEES.

WHEREAS, in January 2007, the Regional Water Quality Control Board issued a Municipal Storm Water Permit to the City for the San Diego region; and

WHEREAS, in November 2007, the City entered into a Memorandum of Understanding with the other copermittees for the sharing of costs required by the permit, with each copermittee to provide its annual budget and appropriate the necessary funds; and

WHEREAS, the Natural Resources & Culture Committee approved the City's proposed budget on December 9, 2009; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial Officer is authorized to expend an amount not to exceed \$610.285 for the City's share of costs in Fiscal Year 2010 necessary to comply with the requirements of the Municipal Storm Water Permit (NPDES No. CAS0108758, Order No. R9-2007-0001), pursuant to the Memorandum of Understanding (City Document No. OO-19699); to be expended as follows: \$138,301 from General Fund No. 100000 and \$471,984 from Storm Drain Fund No. 200301.
