A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE ADVERTISEMENT AND AWARD OF A CONSTRUCTION CONTRACT FOR THE UTILITIES UNDERGROUNDING OF BLOCK 2E, PHASE II IN THE MISSION HILLS COMMUNITY.

WHEREAS, a public hearing before the San Diego City Council was held on March 9, 2004 (Resolution No. 298829) whereby it was found to be in the interest of the public health, safety and general welfare to underground utilities in an area known as Block 2E within the Mission Hills Community; and

WHEREAS, the creation of Underground Utility District Block 2E was authorized by resolution of the San Diego City Council on March 9, 2004 (Resolution No. 298915); and WHEREAS, the City now desires to advertise and award a construction contract to underground Phase II of Undergrounding District Block 2E; and NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. That the plans and specifications for the construction of Utilities Undergrounding of Residential Block 2E, Phase II as advertised by Purchasing and Contracting Department are approved.
- 2. That the Chief Financial Officer is authorized to expend \$4,235,500.00 from CIP A-ID.0001 (Legacy CIP 37.028.0), Utilities Undergrounding of Residential Block 2E Phase II, Fund No. 200218, Undergrounding Surcharge CIP for the construction of Utilities Undergrounding of Residential Block 2E Phase II project and related

expenditures, contingent upon the City Comptroller furnishing a certificate certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

- 3. That the Mayor, or his designee, is authorized to execute a construction contract with the lowest responsible and reliable bidder contingent upon the City Comptroller furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 4. That the Chief Financial Officer, upon the advice from the administering department, is authorized to return excess budgeted funds, if any, to the appropriate reserves.
- 5. Stating for the record that the final MND has been reviewed and considered prior to approving the project; directing the City Clerk to file a Notice of Determination.
