A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ACCEPT, ALLOCATE, AND EXPEND \$2,082,000 IN GRANT FUNDS FROM THE STATE 9-1-1 CUSTOMER PREMISE EQUIPMENT FUNDING ALLOTMENT.

WHEREAS, the San Diego Police Department, Communications Division [Department] is a Public Safety Answering Point [PSAP] for all 9-1-1 calls placed within the City of San Diego; and

WHEREAS, the State of California distributes funds collected from the 9-1-1 surcharge tax through the State 9-1-1 Customer Premise Equipment [CPE] Funding Allotment to all PSAPs for the purpose of upgrading 9-1-1 telephone lines and systems every five years; and

WHEREAS, on November 3, 2003, the City Council approved the acceptance of State

9-1-1 CPE funds for the previous five-year cycle (San Diego Resolution No. R-298538); and

WHEREAS, the State 9-1-1 CPE eligibility funds are determined by PSAP call volume and the Department has been approved to receive \$2,082,000 to upgrade the 9-1-1 call system; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized, for and on behalf of the City, accept and expend \$2,082,000 in grant funds from the State 9-1-1 CPE Funding Allotment to upgrade the Department's 9-1-1 call system.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept, allocate, and expend an amount not to exceed \$2,082,000 in grant funds or the actual amount of

funding authorized by the State 9-1-1 CPE Funding Allotment to upgrade the Department's 9-1-1 call system.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to establish a special interest-bearing fund for the grant, if required.

BE IF FURTHER RESOLVED, that the Chief of Police is authorized to administer and operate the 9-1-1 CPE Funding Allotment grant program.


