A RESOLUTION OF THE CITY COUNCIL AUTHORIZING AN AMENDMENT TO THE COOPERATIVE AGREEMENT WITH CALTRANS FOR THE LAUREL STREET (CABRILLO) BRIDGE OVER STATE ROUTE 163.

WHEREAS, the maintenance of the Laurel Street (Cabrillo) Bridge over State Route 163 is the responsibility of both the City of San Diego and Caltrans; and

WHEREAS, this bridge has been identified by Caltrans as in need of both seismic retrofit and rehabilitation improvements; and

WHEREAS, on September 23, 2008, the City and Caltrans entered into a cooperative agreement that defined responsibility for the preparation of a Project Report, Environmental Document, Plans, Specification, and Estimate to rehabilitate the bridge (Stage 1); and

WHEREAS, a future Cooperative Agreement with Caltrans will provide for Stage 2 of the rehabilitation which would include construction; and

WHEREAS, the original Caltrans estimate of \$3,633,000 to complete Stage 1 of the project has since been revised to \$4,351,300, an increase of \$718,300; and

WHEREAS, the City and Caltrans desire to amend their Cooperative Agreement to add \$718,300 in Caltrans State Highway Operation and Protections Program funds to cover the additional project costs; and

WHEREAS, through this Amendment and the original Cooperative Agreement, Caltrans would continue to completely fund Stage 1 of the bridge rehabilitation and seismic retrofit; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his designee is hereby authorized and empowered to execute, for and on behalf of said City, Amendment No. 1 to Cooperative Agreement with CALTRANS, for the purpose of preparing the Project Report, Environmental Document, Plans, Specifications and Estimate for the seismic retrofit and rehabilitation of the Laurel Street (Cabrillo) Bridge over State Route 163, CIP 53-061.0, S-00939 under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR 305824.
