A RESOLUTION AUTHORIZING A PHASE-FUNDED CONTRACT WITH OLIN CORPORATION TO FURNISH SODIUM HYPOCHLORITE SOLUTION FOR THE POINT LOMA WASTEWATER TREATMENT PLANT; AND **RELATED ACTIONS**

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to establish contract funding phases and award to and execute a contract with Olin Corporation dba Olin Chlor Alkali Products as the lowest bidder per Bid Number 9957-10-C for the provision of sodium solution for wastewater disinfection and odor control at the Point Loma Wastewater Treatment Plant for an amount not to exceed \$3,905,000 [Contract], contingent upon the City Comptroller furnishing one or more certificates certifying that the funds necessary for expenditure under established contract funding phases are, or will be, on deposit with the City Treasurer.

2. That the Chief Financial Officer is authorized to appropriate and expend a total amount not to exceed \$3,905,000 from the Public Utilities Wastewater Operating Fund 700001, for the purpose of executing the Contract, in the following amounts for the corresponding phases, contingent upon the City Comptroller furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be on deposit with the City Treasurer and contingent upon the City Council approving sufficient funding in each fiscal year:

Phase 1 (FY 2010): \$974,000

Phase 2 (FY 2011): \$2,931,000

- 3. That the Mayor, or his designee, shall obtain City Council authorization prior to exercising the options to extend the Contract for additional one (1) year periods, for a maximum of four (4) one-year extensions, with annual per unit cost increases not to exceed twenty percent (20%), contingent upon the City Comptroller furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be on deposit with the City Treasurer.
- 4. That the Chief Financial Officer is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
