A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING THE FISCAL YEAR 2011 BUDGET REPORTS FOR SPECIFIED BUSINESS IMPROVEMENT DISTRICTS AND LEVYING ANNUAL ASSESSMENTS.


