A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING THE MAYOR TO  
EXECUTE THE FISCAL YEAR 2011 OPERATING  
AGREEMENTS FOR THE SPECIFIED BUSINESS  
IMPROVEMENT DISTRICTS.

WHEREAS, the City Council, in accordance with the Parking and Business Improvement Area Law of 1989 (California Streets and Highways Code sections 36500, et seq.), the Parking and Business Improvement Area Law of 1965 (California Streets and Highways Code sections 36000, et seq.), and City Council Policy 900-07 ("Business Improvement Districts"), wishes to continue the promotional activities of specified Business Improvement Districts in the City of San Diego; and

WHEREAS, on MAY 18 2010, 2010, the City Council adopted Resolution No. R- 305855, in which the City Council approved the Fiscal Year 2011 Budget Reports for specified Business Improvement Districts in the City of San Diego; NOW, THEREFORE,
