A RESOLUTION OF THE CITY COUNCIL AUTHORIZING AN AGREEMENT WITH HAWTHORNE MACHINERY COMPANY FOR THE LEASE OF BULLDOZERS FOR MIRAMAR LANDFILL OPERATIONS AND AUTHORIZING EXPENDITURES FOR THE AGREEMENT.

WHEREAS, in December 2008, by Request for Bid No. 9469-09-Y, the City advertised for the lease of heavy duty tractor bulldozers to be used at the West Miramar Landfill; and

WHEREAS, Hawthorne Machinery Company was selected as the lowest responsive bidder meeting City specifications; and

WHEREAS, the Environmental Services Department proposed to continue the two-year contract with Hawthorne Machinery Company effective retroactive to March 15, 2009 through March 14, 2011, subject to Council approval; and

WHEREAS, on April 14, 2010, the Natural Resources & Culture Committee voted unanimously to recommend this contract to the full City Council;

WHEREAS, on May 26, 2010, the full City Council approved a more limited contract term of 16 months effective retroactive to March 15, 2009 through July 14, 2010, pending further discussion; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his designee is authorized, for and on behalf of the City, to enter into an agreement with Hawthorne Machinery Company, the low bidder meeting specifications, for the lease of heavy duty tractor bulldozers with full maintenance for a term of 16 months in accordance with Request for Bid No. 9469-09-Y and Hawthorne Machinery Company's bid in

response thereto, effective retroactive to March 15, 2009 through July 14, 2010, in a total amount not to exceed \$2,167,000 (\$1,625,000 for year one plus \$542,000 for 4 months of year two), as set forth in the Agreement, on file with the City Clerk as Document No. RR- 305868

2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$2,167,000 (\$1,625,000 for year one plus \$542,000 for 4 months of year two) from Refuse Disposal Fund No. 700039, solely and exclusively to provide funds for the above Agreement, contingent on passage of the Annual Appropriations Ordinance for the applicable fiscal year and provided that the City Comptroller first furnishes one or more certificates that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.
