A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH KIMLEY-HORN & ASSOCIATIES, INC. TO PROVIDE TRANSPORTATION PLANNING AND ANALYSIS SERVICES FOR UPTOWN-GREATER NORTH PARK-GOLDEN HILL COMMUNITY PLAN.

WHEREAS, on January 28, 2009, the City Planning & Community Investment Department [CPCI] held a Community Plan Update Kick-off Meeting with members of community to commence updates to the Uptown, Greater North, and Greater Golden Hill Community Plans; and

WHEREAS, as part of the work program for these plan updates, consultant disciplines representing the fields of public outreach, historic resource preservation, urban design, transportation planning, and Environmental Impact Report [EIR] preparation have been identified in the CPCI budget to work as extensions of department staff for these plan upgrades; and

WHEREAS, the City conducted a competitive bidding process and selected Kimley-Horn & Associates, Inc. to provide professional transportation planning and analysis for all three community plan updates; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor and/or his designee is authorized to execute an agreement with Kimley-Horn & Associates, Inc. to provide transportation planning and analysis services for the Uptown-Greater North Park-Golden Hill Community Plan Updates in the amount of \$457,800.

BE IT FURTHER RESOLVED, that the Council authorizes an expenditure of \$457,800 from Fund 100000 for the purpose of executing this agreement.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept an amount not to exceed \$100,000 from the Redevelopment Agency, into Fund 200356, RDA Contributions – NP, and to expend those funds for transportation planning and analysis services for the Uptown-North Park-Golden Hill Community Plan Updates.
