A RESOLUTION OF THE CITY COUNCIL AUTHORIZING FUNDING FOR STORM WATER EMERGENCY PROJECTS RELATED TO PUMP STATION N AND PUMP STATION G.

WHEREAS, Pump Stations N and G in the beach areas sustained significant damage after heavy winter rains; and

WHEREAS, Sloan Electric was selected for emergency services to repair the pump stations and other emergency repairs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Chief Financial Officer is authorized to transfer appropriations in the amount of \$1,250,000 within Fund No. 400002, Capital Outlay-Misc, from CIP S-01098, 4020 Murphy Canyon Road Storm Drain Repair, to CIP ACA-00001, Emergency Drainage Projects Annual Allocation.
- 2. That the City Comptroller is authorized to expend an amount not to exceed \$1,250,000 from Fund No. 400002, Capital Outlay-Misc, in CIP ACA-00001, Emergency Drainage Projects Annual Allocation, solely and exclusively to provide funds for emergency storm drain projects.
- 3. That the Chief Financial Officer is authorized to transfer appropriations in the amount of \$104,752 within Fund No. 400265, General Fund Contributions to CIP, from CIP S-00608, Televising and Evaluation of Storm Drain Corrugated Metal Pipes, to CIP ACA-00001, Emergency Drainage Projects Annual Allocation.

- 4. That the City Comptroller is authorized to expend an amount not to exceed \$104,752 from Fund No. 400265, General Fund Contributions to CIP, in CIP ACA-00001, Emergency Drainage Projects, solely and exclusively to provide funds for emergency storm drain projects.
- 5. That the Chief Financial Officer is authorized to return excess budgeted funds, if any, to the appropriate reserves.
