A RESOLUTION OF THE CITY OF SAN DIEGO AUTHORIZING  
THE SUBMITTAL OF A USED OIL PAYMENT PROGRAM  
APPLICATION TO CALRECYCLE AND RELATED ACTIONS  
FOR THE USED OIL AND OIL FILTER RECYLCING PROGRAM.

WHEREAS, California Public Resources Code (PRC) section 48690 et seq. authorize the Department of Resources Recycling and Recovery (CalRecycle), formerly known as the California Integrated Waste Management Board, to make payments to qualifying jurisdictions for implementation of their used oil programs as required by PRC section 48690 et seq.; and

WHEREAS, in furtherance of this authority, CalRecycle is required to establish procedures governing the administration of the Used Oil Payment Program; and

WHEREAS, CalRecycle's procedures for administering the Used Oil Payment Program require, among other things, an applicant's governing body to declare by resolution certain authorizations related to the administration of the Used Oil Payment Program; NOW,  
THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his designee is authorized to submit a Used Oil Payment Program application to CalRecycle for the City of San Diego to receive payments for implementation of its used oil and used oil filter recycling program.

2. That the Mayor or his designee is authorized and empowered to negotiate and execute, for and on behalf of the City, all documents, including but not limited to: applications,


agreements, annual reports including expenditure reports, and amendments necessary to secure payments from the Used Oil Payment Program to support the City of San Diego's used oil and used oil filter recycling program for Fiscal Year 2010/2011 through and including Fiscal Year 2014/2015.

3. That the Chief Financial Officer is authorized to accept and secure the awarded payments.

4. That the Chief Financial Officer is authorized to appropriate and expend the awarded payments from the CalRecycle Used Oil Payment Program from Fund No. 700048, the Recycling Enterprise, Cost Center 2115111113, solely and exclusively for the City of San Diego's used oil and used oil filter recycling program activities in accordance with the CalRecycle Used Oil Payment Program.
