A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN DIEGO RATIFYING THE ELECTION RESULTS OF THE
MAY 19, 2010 PROJECT AREA COMMITTEE ELECTION FOR
THE BARRIO LOGAN REDEVELOPMENT PROJECT.

WHEREAS, on December 12, 1989, by Resolution No. R-274894, the City Council of the City of San Diego [Council] adopted the formation procedures [Procedures] for the Barrio Logan Redevelopment Project Area Committee [PAC]; and

WHEREAS, on May 20, 1991, the Council adopted Ordinance No. O-17644 (NEW SERIES), thereby approving and authorizing the Redevelopment Plan for the Barrio Logan Redevelopment Project Area [Project Area]; and

WHEREAS, on May 20, 2003, by Resolution No. 297999, the Council directed that the Procedures for the Redevelopment Agency, Community and Economic Development administered Project Area Committees, including the PAC, be amended; and

WHEREAS, on December 8, 2003, by Resolution No. R- 298704, the Council amended the Procedures; and

WHEREAS, California Community Redevelopment Law [Law] requires that project area committees remain in existence for three years from the date of adoption of the redevelopment plan and are thereafter subject to one-year extensions by the legislative body; and

WHEREAS, on or about March 23, 2010, the Council, by Resolution No. R-305704, approved a one-year extension of the PAC and directed the Redevelopment Agency staff to notice and conduct the annual PAC election for 2010; and

WHEREAS, after notice and in accordance with the Procedures, the PAC Bylaws, and applicable law, the annual PAC election was duly conducted by Agency staff on May 19, 2010; and

WHEREAS, a representative from the City Clerk's Office attended the annual PAC election to ensure its validity and provide official verification of the tallying of ballots; and


WHEREAS, this activity is not a "project" within the meaning of the California Environmental Quality Act [CEQA], specifically CEQA Guidelines Section 15378, and thus is not subject to CEQA pursuant to CEQA Guidelines Section 15060(c)(3); NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego [Council] as follows:

1. That the Project Area Committee [PAC] for the Barrio Logan Redevelopment Project, including those persons who received the highest number of votes in their respective categories and listed on the City Clerk's Office's verification of election results attached hereto as Exhibit "A" and incorporated herein by this reference, is hereby approved as constituting a representative PAC.

2. That the Council finds the election results of May 19, 2010 are valid and binding in accordance with the Procedures adopted by Resolution No. R-298704.
